MESSAGE FROM THE PRESIDENT

2016 has been an incredible year!

This year has seen MIT Group Foundation undertaking an unbelievable amount of work alongside the many volunteers and stakeholders that have worked with us.

As the world stood still for a moment or two after the shocking earthquakes in Nepal of April 2015, we have continued to see the devastation that a few horrifying minutes caused for the incredible Himalayan landscape of Nepal. The recovery work that is still happening has taken a great deal of effort, working and liaising with Governments, contractors and of course the wonderful volunteers that continue to work relentlessly rebuilding and reconstructing the many villages that were affected.

I take this opportunity to thank everyone who has been involved, particularly with the relief efforts in Nepal whether in monetary donations, or in kindly offering their time and efforts, without whom none of the very necessary work and fund raising would have been possible.

MITGF, our local foundation - MITGF Nepal, along with the NRNA have already made an incredible difference to the lives of many. Through the work of our in-country partner, NRNA, Stage 1 (Relief) of the Nepal Earthquake project has been successfully completed which provided urgent essential relief (food, shelter and medical treatment) to thousands affected in the immediate aftermath of the earthquake.

I thank my fellow NRNA members and the Secretariat for standing with me and their efforts to date and to making every effort to ensure that the next Stage 2 (Rebuild) will run smoothly in Nepal.

Whilst we continue to work with the reconstruction of Nepal, much time and effort has also gone into other projects like the building of the Shree Gram Kalyan Secondary School Building Project in Naung, Lamjung, Nepal. We are proud of having been instrumental in building this 2 storey community school, which has seen 1,200 people and 200 students benefit from the use of the building. The school was officially inaugurated in October 2015 by the Australian Ambassador to Nepal, his excellency, Mr Glen White.

We continue to look forward to the challenges ahead, not only in the rebuilding and recovery of Nepal, but also in other projects.

2017 will see us concentrating on many more new projects with a focus on Education and Health. With the support of the MITGF Directors, our volunteers and of course our sponsors we will continue to grow as an organisation to complete the work we have already started and look forward to more challenges.

About the Founders

History and Founders

Mr. Shesh Ghale, and Ms Jamuna Gurung were both born in Nepal and are now living in Melbourne, Australia.

Together they built a substantial commercial property portfolio and founded Melbourne Institute of Technology (MIT), a Melbourne based Education Provider with a campus in Sydney; of which, Mr. Ghale is CEO and Ms Gurung is Managing Director.

Both Mr. Ghale and Ms Gurung have a strong dedication to education and the welfare of the under privileged; they promote entrepreneurship and continue to work constantly towards ways of improving the lives of many.

In 2013 Mr. Ghale was honoured by being voted for his first term as President of the NRNA, (Non Resident Nepali Association, which is, a not for profit voluntary organisation with members contributing a great deal of time and resources for the betterment of the lives of Nepalese in general and finding ways of bringing work and pride back to the youth and people of Nepal.

She was formerly the Senior Deputy Vice-Chancellor, University of Ballarat/Federation University Australia, and has previously served as a Director on a number of Boards.


She is the Principal, Rowena Coutts Management Consulting, since 2014.

Our Work



Nepal Earthquake

Midday 25th April of 2015, marked dark days for the Nepalese communities when a 7.8 Richter scale earthquake hit its shores and impacted the country on an unprecedented scale. The Epicentre of the original quake was the Ghurkha area, which is about 80km northwest of Kathmandu. More destruction and quakes were to follow in the following days.

The initially reported statistics were horrendous, noting over 9,000 people dead, 25,000 injured and more than a million displaced from their homes. It was said that more than a million homes; 30,000 classrooms in 8,000 schools and over 500 health centres had been destroyed or badly damaged.

Stage 1 (Relief) focused on the immediate relief needs of the local Nepalese people in the short term, with MITGF raising NRP.20 million (Approx. AUD\$250,000) for assistance to these areas and people.

NRP 2.2 million was spent on Stage 1 covering the immediate relief operations which targeted those locations listed by the Nepalese Government as being the most in need of relief. This involved providing affected families and households with tents/tarpaulins for temporary shelter, food, blankets, sleeping bags and setting up medical camps to provide treatment to the injured.

With the united efforts of MITGF & NRNA and working in tandem with the Government, they were able to mobilize over 300 volunteers, who were there to provide initial temporary shelter, food and clothing. There were huge numbers of people who had no homes or shelter, no food and the weather was not on their side either. The monsoon season was not far and it was clear that work needed to commence immediately.

Mr. Ghale (MITGF President) and his wife Ms Gurung not only supported the immediate relief effort of Nepal earthquake victims through NRNA, but worked on the ground themselves, giving alms and helped distribute food, temporary shelter, blankets and clothing.

They, along with the many other volunteers, through NRNA were able to provide:



- *17,000 tarpaulins for temporary shelter to 13 districts
- *15,000 blankets
- *171,000 packets of noodles to more that 14,000 families
- *Over 73 tonnes of rice and 5 tonnes of beaten rice
- * 26 medical camps set up in these areas, assisting in medical treatment for 10,000 people

Shelters were built to assist the more vulnerable families and in particular in the Gumshi Pakha Danda region.

There were many challenges faced by the volunteers, not least, the topography of the land as many of the regions could not be reached by vehicular transport .

The remaining funds provided by MITGF (NRP 17.7 million) will be allocated to Phase 2 (Rebuild), that includes the reconstruction of houses in Laprak VDC of Gorkha and other Districts.

MITGF and NRNA's goal is to rebuild 1,000 homes for those who were most affected by the earthquakes. On the 24th April a tripartite was signed with National Authority (NRA) and the Ministry of Urban Development (MUD) which was to make this goal possible.

In order to monitor not only the progress, but also, that the funds raised are being used in the intended way,

representatives of MITGF / NRNA along with national and foreign dignitaries have visited and to continue to visit the site regularly. The visits which have been many are held to see and discuss the progress of the project going forward. And reports are undertaken at intervals and presented to all stakeholders.

To ensure that the correct locations and types of homes are built, experts have been engaged to undertake a number of studies and to report back the best solutions.

- ⇒ Surveyors were sent to Larpak in May 2016 to prepare a contour map (topographic map) of Ghumsipakha, the intended area chosen for relocation
- ⇒ As a result of the study, cabinet has agreed to provide 18.32 hectares of government land for resettlement


There were a number of challenges in undertaking the project namely, getting the support of government bodies; beating the monsoon period; relocating of the beneficiaries during the reconstruction stage; remoteness; harsh winter; seasonal road conditions and cash flow management.

Moving forward

From our experience to date, MITGF and NRNA have learnt a number of lessons which will be used to help improve our future activities.

Future planning will need to include:

- ⇒ Tendering for more consultants and contractors
- ⇒ Training volunteers
- ⇒ Ensuring that funds are readily available as they are needed
- ⇒ Ensuring that the NRA are developing the infrastructure to meet the needs of the new locations, which include roads, electricity supply and the supply of drinking water
- ⇒ Planning and managing the project and focussing on the inaccessibility due to harsh weather conditions
- ⇒ Construction commencement and continuity to be on track
- ⇒ Putting in place mechanisms to disseminate and receive community guarantee loan of Rp300 thousand provided by the Nepalese government
- ⇒ Identifying and encouraging further funding for more projects to continue the rebuilding of Nepal.



Nepal Humanitarian Crisis– Essential Medical Supplies

The human crisis that was present in the aftermath of the quakes was incredible. Not only were there many people who died as a result of the quakes but there were so many more, injured, with little or no medical supplies; or places to treat them in. In addition, the blockades that stopped supplies into the country compounded the situation even further. To get assistance it was necessary to work as a group and look at ways to resolve the very difficult situation at hand.

In order to reach out and assist as many people as they could, MITGF, signed an MOU with NRNA so that they could work together to ensure medical supplies and assistance could be given to as many as possible of these many people.

The formed groups that worked in consultation with representatives from the Nepal Government so that they could determine what essential medicines/drugs and medical supplies were required. Once the list was finalised

they were then able to acquire and distribute to areas that needed the medical supplies.

As a result of their combined efforts is allowed them to acquire 4 lots of essential medicines which were then distributed through the community hospitals throughout Nepal.

This was only possible with the support and assistance of the government of Nepal.

Mr Shesh Ghale as NRNA ICC president and CEO of MITGF lead the formation of the NRNA Emergency Crisis Management Team, who were responsible for coordinating the project activities. He was also present at each of the 4 handovers for the medical supplies.

MITGF provided RPS 10 million (Approx. AU\$135,000) for the project of which RPS 5,231,245 was utilised for the project immediately leaving a residual of RPS 4,768,755 which were returned to the foundation, for other works.

Shree Himalaya Higher Secondary School



Whilst lives and homes had been lost, those that were lucky enough to live through it had lost so much. Their 'normal' lives had been disrupted dramatically. For children and young people still at school it meant that they could not attend school and be educated; so many schools were impacted by the devastation caused by the Earthquakes. One such school that had been badly affected was the Shree Himalaya Higher Secondary School.

The two founding members of MITGF understood the need and the urgency of the situation, they were on the spot, helping and assisting the neediest and understood all too well, how important it was, to ensure that the students of this and many others like it, did not miss out on their education. They believe in Education being a gateway to successful lives and that it gives purpose to the lives of youth.

They understood the importance of trying to provide normality in their day to day lives, and so in an effort to rebuild the confidence and morale of not only the students but their parents, MITGF donated NRP 19, 00000 (approx. AUD\$20,000) to our local Foundation, MITGF Nepal, to build a temporary school which contained 24 classrooms.

As the monsoon period was fast approaching, they were cognisant of the fact that the school building could also provide shelter that doubled up as a community centre during the monsoon season. This building could shelter families from the rain and hail, given that so much around them had either been destroyed or badly damaged. This project has been completed and the community have benefitted from it in their time of dire need and continue to have use of it and will continue to rebuild and get on with their lives.

Shree Gram Kalayan Middle School Building Project

In addition to the work done for the relief and immediate assistance after the Nepal earthquakes, MITGF continued to work on projects that would improve schools in Nepal. One of the inaugural projects undertaken by the Foundation was to fund the building of a much needed new community school for the District of Ghanpokhara, Lamjung. This work was carried out by MITGF Nepal.

The new Shree Gram Kalyan Lower Secondary School Naung Ghanpokhara - 9, Lamjung opened officially on the 4th October 2015, inaugurated jointly by MITGF President, Mr. Shesh Ghale and his excellency, Mr. Glen White, the Australian Ambassador to Nepal .

The cost to complete the building was NRP 6.9 million, of which MITGF contributed NRP 4.4 million (approx. AUD\$55,000). The school was named in honour of Mr. Ghale's mother, Mrs. Devi Kumari Ghale and his late Father Mr. Udim Bahadur Ghale.

Mrs. Devi Kumari is now the patron of the School.

This project involved the construction of a 2 storey school building, housing 8 classrooms.

The school had been providing educational services for the local students for many decades. When Mr. Ghale and Ms Gurung visited the school it was very apparent to them that the school and its facilities were very badly deteriorated and in need of urgent repairs. As this was the area that they had both grown up in, it was disturbing to them to see this familiar school so decrepit. The initial work carried out was to undertake an evaluation of what should be done to make the required changes. They sought the expertise of the East West Engineering Services (EWES) to carry out a detailed feasibility study and site analysis. The report confirmed that the state of the current school was unsafe, particularly the roof; doors were warped; windows were not functioning and the deteriorating walls were not strong enough to weather storms, particularly the seismic type, which the area is prone to.

This project is now successfully completed, with the school now being built to withstand the area's earthquake conditions. The building project was personally monitored by MITGF's President and CEO who undertook regular visits to the region and met with the builders etc. and ensured that the funds provided were properly managed.

This project was a very successful one, achieving the foundation's goals in a very short period of time and well within budget. The beneficiaries are more than happy and satisfied with the outcome. The building of this school has meant that 1,200 people and 200 students have been able to use the facilities.

This facility has been built to allow people of the district, without bias, to use the building and with the intent that it be a sustainable building that will stand for many more years of use.

Not only does this building house the students of the region but also serves as a meeting place. As with all projects, this one was not without challenges during the building stages.

The lack of water due to the topography was one of the more difficult challenges, given that the area was situated on top of the mountains. The much needed water had to be transported in pots so that construction could continue.

In addition, not only the water but building materials transportation was a very challenging process as, again due to the very roughly built roads and the need to carry up hill, it was not possible to transport building materials by vehicles.

Another such challenge was the language barrier as the school managers did not speak English fluently. Reporting was more difficult, but, managed to get the message across.

In evaluating the effectiveness of this project, MITGF directors realised that there was a need to do more communication and reporting between stakeholders.

With this particular project once finished, the school managers did advise that there were concerns about the quality of the paint used; that the painting may not be to the standard required in a temperature such as is normal in the region. Better communication with stakeholders would have avoided this issue.

For future projects which have similar challenges, MITGF will need to clearly look at the challenges and plan accordingly.

Financial Statement

Summary

This year marks the second year of operations for MITGF and significant achievements have been made. In its very short term of operations, AUD\$185,000 have been contributed to the projects undertaken for the financial year 2015/2016 and sent to the communities in Nepal, via its associated local foundation MITGF Nepal and via NRNA (non Resident Nepali Association).

For this financial year, the founders, Mr Ghale and Ms Gurung have donated AUD\$200,000 to MITGF.

There were some very notable highlights for this year, including *The Nepal Humanitarian Crisis – Essential Medical Supplies Project*, delivered by the in country partner NRNA. The Foundation contributed NRP10 million (approx. AUD\$135,000) to NRNA to this project to provide for essential life saving medical supplies. It was particularly fraught with the most dreadful challenges when blockades were set up on the Indian border blocking medical supplies. With the help of the Nepal government, four lots of medical supplies were acquired and distributed to community hospitals in Nepal.

The second of these highlights was the completion of The Shree Gram Kalyan Lower Secondary School Naung, Ghanpokhara-9, which was delivered by in country partner MITGF Nepal where the Foundation contributed NRP 4.4 million (approx. AUD\$55,000).

Looking forward the Foundation will continue to raise and spend money on projects centred around Health and Education. We will continue to support NRNA in realising the building of 1,000 homes for those most affected by the quakes and commencing with the Gorkha District which was the epicentre of the earthquake.

Overall, MITGF remains financially stable, with the founders having pledged to contribute a NRP 1 billion (approx. AUD\$12.5million) in the long term for the Foundation is to be spent in the areas of Education and Health.

To carry out the company's strategies and to achieve its short-term and long-term objectives, the company engaged in the following principal activities during the year.

The principal activity of the group during the year was to provide funds to support advancing health, education and social or public welfare in developing countries.

DIRECTORS' REPORT

Key performance indicators

To help evaluate whether the activities the company established during the year have achieved its short-term and long-term objectives, the company uses the following key performance indicators to measure, analyse and monitor its performance:

In only its second year of operations, MIT Group Foundation Ltd has made significant achievements by contributing AUD\$185,000 in the 2015/2016 financial year to the communities in Nepal via its associated local foundation (MITGF Nepal) and via NRNA – Non Resident Nepali Association.

The projects which we have successfully completed during the year included:

Nepal Humanitarian Crisis – Essential Medical Supplies Project delivered by in-country partner, NRNA in which MITGF contributed AUD\$135,000 (NRP 1 million) for the provision of essential life-saving medical supplies during extended essential supply blockade in Nepal's Indian borders (between October 2015 and March 2016). Representatives from the Nepal government were consulted to determine the list of essential medicines and medical supplies, and a total of 4 lots of medical supplies were acquired and with the assistance of the Nepal Army, delivered and distributed throughout needed community hospitals in Nepal. MITGF's President and CEO, Shesh Ghale was present at each of the 4 handover of essential medical supplies. Of the funds provided by MITGF, only NRP 5,231,245 was utilised for the project, with NRP 4,768,755 left over which will be refunded to MITGF in accordance with the MOU between MITGF and NRNA.

Shree Gram Kalyan Secondary School Building Project

Project delivered by in-country partner, MITGF Nepal which involved the construction of a new 2 storey school building comprising of 8 classrooms located in the village of Naung Lamjung District. MITGF contributed NRP 4,401,700 (Approx AUD\$55,000) for this project which was successfully completed despite the inherent challenges posed by the isolated site location on the top of a mountain, including the logistic difficulties of transporting materials and the lack of water supply.

The new school has been built to withstand earthquake conditions and will help provide much needed education to some 200 students in the local community. It was officially inaugurated jointly by the Australian Ambassador to Nepal, his Excellency, Mr Glen White and MITGF's President Shesh Ghale on 4th October 2015.

Looking ahead, much work still needs to be done from the Nepal Earthquake of April 2015 and the devastation it caused, including destroying some 450 public health infrastructures, 8500 schools, and more than 400,000 homes. MITGF will continue to work with its in-country partner, NRNA in the Nepal Earthquake Relief and Rebuild Project.

Phase 1 of the project (Relief) was successfully completed and the following major results achieved:

- 17,000 tarpaulins for temporary shelter in 13 districts
- 15,000 blankets distributed
- 171,000 packet noodles to more than 14,000 families
- Over 73 tons of rice and 5 tons of beaten rice
- Setting up 26 medical camps to assist treat over 10,000 people

MITGF will work with NRNA in Phase 2 (Rebuild) and focus its efforts to rebuild in those earthquake ravaged villages and regions. We support NRNA's stated goal to rebuild 1000 homes for those most affected by the earthquake and with the signing of the tripartite agreement between NRNA, the National Reconstruction Authority and the Ministry of Urban Development, the rebuilding of homes will start for those families in the Laprak VDC of Gorkha District, which was the epicentre of the earthquake. Our commitment and strategy for mid and long term are to spend NRP 1 billion which is equivalent to 12.5m AUD on current exchange rate. This amount was pledged by MITGF founders and directors, Shesh Ghale and Jamuna Gurung in January 2015 in the areas of Education and Health.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The financial report is a general purpose financial report that has been prepared in accordance with Australian Accounting Standards - Reduced Disclosure Requirements, Interpretations and other applicable authoritative pronouncements of the Australian Accounting Standards Board.

The financial report was approved by the members as at the date of the committees' report.

The financial report is for the entity MIT Group Foundation Ltd as an individual entity. MIT Group Foundation Ltd is a company limited by guarantee, incorporated and domiciled in Australia. MIT Group Foundation Ltd is a not-for-profit entity for the purpose of preparing the financial statements.

The following is a summary of the material accounting policies adopted by the company in the preparation and presentation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

(a) Basis of preparation of the financial report

Historical Cost Convention

The financial report has been prepared under the historical cost convention, as modified by revaluations to fair value for certain classes of assets and liabilities as described in the accounting policies.

(b) Going concern

The financial report has been prepared on a going concern basis.

The company has deficiency in working capital and net asset deficiency as at 30 June 2016 of \$2,912 (2015: 8,471).

The Company has obtained a letter of support from Melbourne Institute of Technology that it will not seek repayment of the loan of \$17,050 owing as at 30 June 2016. Melbourne Institute of Technology has also confirmed they will continue to provide financial support to the Company to enable it to continue as going concern and to meet their obligations as and when they fall due in the normal course of business.

(c) Revenue

Income arising from donations shall be recognised when:

- a) the entity obtains control or the right to receive the donation;
- b) it is probable that the economic benefits comprising the donation will flow to the entity; and
- c) the amount of the donation can be measured reliably.

All revenue is measured net of the amount of goods and services tax (GST).

(d) Income tax

No provision for income tax has been raised as the company is exempt from income tax under Division 50 of the *Income Tax Assessment Act 1997*.

(e) Cash and cash equivalents

Cash and cash equivalents include cash on hand and at banks, short-term deposits with an original maturity of three months or less held at call with financial institutions, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities in the statement of financial position.

(f) Foreign currency translations and balances

Functional and presentation currency

The financial statements are presented in Australian dollars which is the company's functional and presentation currency.

Transactions and Balances

Transactions in foreign currencies of the company are translated into functional currency at the rate of exchange ruling at the date of the transaction.

Foreign currency monetary items that are outstanding at the reporting date (other than monetary items arising under foreign currency contracts where the exchange rate for that monetary item is fixed in the contract) are translated using the spot rate at the end of the financial year.

Except for certain foreign currency hedges, all resulting exchange differences arising on settlement or re-statement are recognised as revenues and expenses for the financial year.

(g) Comparatives

Prior year financial statements relates to 11 December 2014 to 30 June 2015 and accordingly the amounts presented in the financial statements are not entirely comparable.


